#### Proposed Soil Sampling

A minimum of five soil borings will be advanced using an environmental drill rig to vertically and laterally delineate impacts observed associated with the historic blow down pit. One soil boring will be advanced in the center of the historic pit, adjacent to the PIT C sample and one in each cardinal direction immediately outside the historic pit footprint. As each soil boring is advanced, the soil will be characterized through visual and olfactory observations and field screening soil samples for volatile organic compounds using a photoionization detector (PID). Discrete soil samples will be collected and submitted from the depth of highest impacts as well as from the terminus of each boring. Contingency borings will be advanced if impacts are observed in the proposed sample locations in order to delineate the horizontal extent.

Due to limited winter access, no assessment activities were completed at the Site during Q4 2022. Activities are scheduled for the spring/summer 2023.
