Laboratory analytical indicated a historical release occurred along the FHA 2-1 decommissioned flowline. Four soil sampled exceeded COGCC standards for 1-methylnaphthalene at 0.017 mg/kg, 2-methylnaphthalene at 0.0227 mg/kg, benzo(a)anthracene at 0.383 mg/kg, benzo(a)pyrene at 0.258 mg/kg, naphthalene at 0.0433 mg/kg, and pyrene at 1.68 mg/kg.
