During this inspection the following compliance issues were observed:

1. Housekeeping - Stained soils & gravel on location with a CA date of 04/21/2023
2. Unmarked deadman with a CA date of 04/25/2023
3. Containment liner needs maintenance with a CA date of 05/01/2023
4. Meter calibration info not conspicuously posted with a CA date of 04/21/2023
