Location # 335244 in Garfield County Colorado.

Location is within High Priority/Density Habitat areas & within close proximity to NSO Habitat & Bald Eagle Roost site.

Location is approximately 675 yards from the Colorado River.

While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

1. Meter calibration info not conspicuously posted with a CA date of 04/18/2023
2. Stormwater - Lack of stabilization/Insufficient tracking BMP's with a CA date of 04/23/2023

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
