This is incorrect since the transfer has not been approved.</p> <p>Solution 1: Please resubmit all 15 of the Wells and Facilities Transferred spreadsheets listing the current operator reflected in COGIS.</p> <p>Problem 2: For the last two Subsequent documents (402891710 and 402891752), the Incidents Transferred spreadsheets listed the current operator as Scout Energy Management LLC. This is incorrect since the transfer has not been approved.</p> <p>Solution 2: Please resubmit both of the Incidents Transferred spreadsheets for subsequent document #402891710 and #402891751 listing the current operator reflected in COGIS.</p> <p>Problem 3: There are Related Wells and Facilities that are not accounted for in the transfer.</p> <p>Solution 3: I have attached a workbook that lists the Related Wells and Facilities that are not accounted for.
