General Comment:**COGCC Inspection Report Summary**

On Tuesday 4/11/2023, I, Inspector Scott Ramsey, conducted a routine inspection at KT Resources WRD Wyatt 36-33, at Location # 316142 in Rio Blanco county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area.

During this inspection the following compliance issues were observed:

1. Some areas of location show signs of lack of stabilization which in turn can lead to tracking issues.
 2. Access road shows signs of lack of stabilization
 3. No API posted on well head or battery signage.
 4. Stored/unused chemical tank.
 5. Random staining.
 6. Meter calibration card not conspicuously posted.
