On Tuesday, 4/18/2023, Inspector Kirby Burchett, conducted a routine field inspection at KT Resources LLC on the Ant Hill Unit 29-13 well, Location #316307, in Rio Blanco County, Colorado.

This location is within or in close proximity to Parks and Wildlife (CPW) District with High Priority/NSO/Density/Other Consultation Habitats.

Any Corrective Actions from previous Inspections are still applicable.

While there during normal production operations the following compliance issues were observed:

1. API Number not displayed on tank battery sign.
2. Gas meter calibration card not visibly displayed.
3. Insufficient BMPs to control vehicle tracking.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with COGCC rules.
