Comment: According to the Global Reclamation Plan, additional reclamation was performed back in 2021. However, the well location is mostly bare ground and weedy, annual vegetation that is not reflective of reference areas.

Note- the associated offsite tank battery will be inspected under a separate field inspection report related to another well location and for another Operator (Noble).

Corrective Action:	<p>Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p> <p>The corrective date is the date the location was observed out of compliance.</p>	Date	04/27/2023
