Comment **This location does not comply with Rule 1003. It appears the Operator has performed interim reclamation activities with evidence of desirable perennial plant species observed throughout the location. However, Staff observed undesirable plant species (e.g. russian thistle) around the production areas, and areas of non-uniform vegetation cover resulting in areas of bare soil in the reclaimed portions of the location. Additional reclamation activities and weed management will be required to meet Rule 1003 standards. Refer to attached inspection photos for documentation.**

Corrective Action **Perform reclamation in accordance to Rule 1003. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards. Corrective action date is the date the location was observed out of compliance.**
