On Tuesday 5/9/2023, I, Inspector Scott Ramsey, conducted a routine inspection at KPK Dwinell 3-A, at Location # 323666 in Jackson county Colorado.

While there, I observed normal operations. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife black bear Management and Density habitat.

During this inspection the following possible compliance issues were observed:

1. No evidence of any storm water controls to prevent sediment migration or tracking BMP's to prevent sediment from location being transported from location.
2. Cut slope shows signs of lack of stabilization.
3. Random debris
4. Weeds around location and equipment
