**COGCC Inspection Report Summary**

On Monday 5/8/2023 at approximately 10:38 hours, I, Inspector Tom Peterson, conducted an on-site follow up inspection at the KPK McCarty #2 location #33270 in Weld County, Colorado.

While there, I observed that the DCP gas sales meter station #235317 appeared to have current product sold. The following possible compliance issues were observed: Immediately cease all gas sales pursuant to Order 1V-863 with a corrective action date of 2/23/2023.

Further gas sales from this battery is a violation of Rule 219 and Order 1V-863. Wells associated with this battery are McCarty 10-21 API #123-26729.

A follow up on this site inspection needs to be conducted to ensure that compliance issues have been corrected to comply with COGCC rules.
