<p><b>COGCC Inspection Report Summary</b></p> <p>On Monday 5/8/2023 at approximately 14:25 hours, I, Inspector Tom Peterson, conducted an on-site follow up inspection at the KPK Stroh #1 location #319250 in Weld County, Colorado.</p> <p>While there, I observed that the DCP gas sales meter station #232790 appeared to have current product sold. The following possible compliance issues were observed: Immediately cease all gas sales pursuant to Order 1V-863 with a corrective action date of 2/23/2023. Further gas sales from this battery is a violation of Rule 219 and Order 1V-863. Wells associated with this battery are: Stroh #1 API #123-10865, Stroh 33-1 API #123-24142, Stroh 33-4 API #123-24143, Stroh 33-2 API #123-24146, and the Stroh 7-33 API #123-26390.</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.</p> <p>This is a summary of the inspection report.</p>	petersont	05/08/2023
