**General Comment:****COGCC Inspection Report Summary**

On Tuesday, 05/09/2023, Inspector Kirby Burchett, conducted a follow up field inspection at KT Resources LLC on the WRD Wyatt 36-14 well, Location #316241, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District with High Priority, NSO, Density, and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

Follow up inspection to verify Corrective Actions from Inspection #702501018 on 3/21/23 have been addressed. Chemical tank label has been applied. Chemical tank containment full of liquid and Stormwater BMPs have not been addressed.

While there during normal production operations the following compliance issues were observed:

1. Tank battery sign missing API Number.
2. Chemical tank containment full of liquid.
3. Ground staining below fire tube on separator.
4. Gas meter calibration card not visibly displayed.
5. Stormwater BMPs have not been implemented or maintained.

Refer to Inspection Photos for observed compliance issues.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with COGCC rules.
