**MEMORANDUM OF AMENDMENT AND RATIFICATION OF
SURFACE USE AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS:

That STEPHEN D. TEBO, herein referred to as "Surface Owner", whose mailing address is P.O. Box T, Boulder, CO. 80306-1996, and CONOCOPHILLIPS COMPANY, herein referred to as "Lessee", whose mailing address is, **REAL PROPERTY ADMINISTRATION, P.O. BOX 7500, BARTLESVILLE, OK 74004-7500** have entered into a an Amendment and Ratification of Surface Use Agreement dated effective as of the 1st day of March, 2011 ("**Amendment**").

WHEREAS, Surface Owner and Lessee executed that certain Surface Use Agreement dated effective March 1, 2011, a Memorandum of which is recorded at Reception #D1093566 in the real property records of Arapahoe County, Colorado, covering the following described lands ("the Property"), for the purpose of facilitating the coordinated development of the surface and mineral estates in the Property:

Township 4 South, Range 64 West, 6th P.M.

Section 28: W/2

Section 29: All

Section 32: All

Section 33: W/2

Township 5 South, Range 64 West, 6th P.M.

Section 1: Lots 1 (80.50), 2 (81.46), S/2N/2, S/2 (All)

Section 3: Lots 1 (78.76), 2 (77.67), S/2N/2, S/2 (All)

Section 4: Lots 1 (77.53), 3 (38.99), 4 (39.14), S/2N/2, S/2 (All)

Township 5 South, Range 63 West, 6th P.M.

Section 6: Lots (82.40), 2 (40.60), 3 (77.43), 4 (78.08), S/2NE/4, SE/4NW/4, E/2SW/4, SE/4 (All)

WHEREAS, for adequate consideration, Surface Owner and Lessee have entered into an Amendment and Ratification of the Surface Use Agreement by which Surface Owner clarifies Lessee's rights and obligations under the Surface Use Agreement and acknowledges that the Surface Use Agreement is valid and in full force and effect.

Among other provisions, the Surface Use Agreement grants Lessee certain rights and Surface Owner hereby grants to Lessee certain rights (subject to all terms and conditions of the Surface Use Agreement), in the Property to drill, complete, produce, deepen,

rework, frac, refrac and recomplete directional wells from surface locations within the prescribed drilling areas on the Property to bottom hole locations on lands adjacent to the Property in which Lessee holds an oil and mineral or leasehold interest.

Surface Owner and Lessee have agreed to record this Memorandum in the real property records of Arapahoe County, Colorado, to provide notice to third parties of the Amendment and Ratification of Surface Use Agreement.

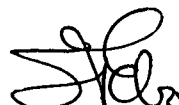
This Memorandum is signed by Surface Owner and Lessee on the date of acknowledgement of their signatures, but is effective as of March 1, 2011.

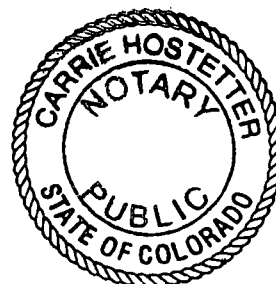

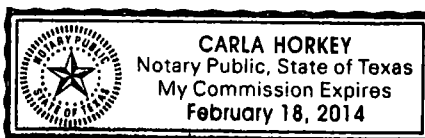
