<p>COGCC Inspection Report Summary</p> <p>On Wednesday 5/10/2023 at approximately 11:05 hours, I, Inspector Tom Peterson, conducted an on-site follow up inspection at the KPK Kammerzell 1-9 battery API #123-11436 in Weld County, Colorado.</p> <p>While there, I observed that the DCP gas sales meter station #23149 appeared to have current product sold. The following possible compliance issues were observed: Immediately cease all gas sales pursuant to Order 1V-863 with a corrective action date of 2/24/2023. Further gas sales from this battery is a violation of Rule 219 and Order 1V-863. Wells associated with the battery are Kammerzell 1-9 API #123-11436 and Kammerzell 7-4 API #123-22643.</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.</p> <p>This is a summary of the inspection report.</p>	petersont	05/10/2023
