	<p>Scotch thistle, a List B Noxious Weed was observed occasionally throughout the location.</p> <p>Perennial grasses are well established in the former interim areas of the location. However, they do not appear to have reached eighty (80) percent of reference by ocular estimate. There is little successful revegetation in the center of the location, at the former working pad area. However, young perennial grasses were observed in poorly vegetated areas which may become established. Therefore, no corrective action is given to allow young grasses to establish. It is unclear if additional seeding is necessary at this time. Operator shall continue to monitor and manage the site to ensure the site progresses towards 1004 vegetation standards.</p>	
Corrective Action:	<p>Conduct weed management to prevent further establishment and spread of noxious weeds; ongoing weed management required until location passes final reclamation.</p>	Date 06/01/2023
