General Comment:**COGCC Inspection Report Summary**

On Thursday, 5/18/2023, Inspector Kirby Burchett, conducted a follow up field inspection at Locin Oil Corp. on the N. Douglas Creek 3-33-1 well, Location #315416, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District with Black Bear, High Priority, NSO, and Density Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

Follow up Inspection in response to Corrective Actions from Inspection #702500120 on 4/7/23. All CA's but Stormwater have been addressed.

While there during normal operations the following compliance issue was observed:

1. Random debris.
2. Open end tank valve.
3. Oil leak with liquid on the ground and stained soil.
4. Stormwater BMPs have not been implemented.

Refer to Inspection Photos for observed compliance issues.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with COGCC rules.
