**Photo 1.** Facing west at compressor station. Unknown fluid observed within the engine skid; previous inspections required the Operator to contain and clean up antifreeze within the skid and perform maintenance on the equipment to ensure mechanical integrity (e.g. fix origin of leak). Based on documentation in FIRR (doc#403379517) the operator cleaned up the antifreeze (and drained it) but did not indicate if equipment was worked on/repared. Staff is uncertain if rainfall mixed with residual chemicals on the skid or if the equipment has a mechanical failure elsewhere.

**Photo 2.** During this inspection, Staff observed that the interim reclamation areas do not appear to be progressing towards 1003 standards. Undesirable vegetation (e.g. kochia) and Colorado List B Noxious Weed (e.g. canada thistle) and a List C (e.g. cheatgrass; outlined in red) was observed growing throughout the interim areas and will need to properly managed for during the local growing season to prevent spread onto adjacent lands.

**Photo 6.** Facing west near the southern portion of the production area. Staff observed hydrocarbons mixed with stormwater and was unable to determine how much material was onsite. The berm material also had a noticeable sheen and chemical odor, which will need to be properly cleaned up and removed. After review with Environmental Staff this is a reportable spill per Rule 912.b.

**Photos 13 & 14.** Staff observed multiple vehicles parked on location. Verdad personnel (D. Wagoner) informed Staff that vehicles were temporarily parked on location due to a safety concern at a nearby location (462872) that was in the process of fracking wells. Staff acknowledges the safety concern and also wants to remind the Operator that locations are not to be used for equipment storage; relocate vehicles/equipment when conditions allow safe operation.
