Operator Comment: The photos associated with this inspection misrepresent the fact that this is an access road to the well that Impetro has permanent and unabridged access to per our surface use agreement. The road to this location (See attached screenshot from Google Earth) is not as well defined as our access roads in the non-crop sections of our lease out of respect to the landowner during growing season. Foot travel is predominantly used during the growing season to make site inspections. Nevertheless, Impetro can access this location whenever needed via this road by vehicles, as needed.

Pursuant to 1003.b. All disturbed areas affected by drilling or subsequent operations, except areas reasonably needed for production operations to be commenced within twelve (12) months; Impetro just conducted a workover of this well on 4/17/2023 and this inspection took place on 4/20/2023. Impetro is working with the landowner to reestablish areas surrounding the well that are not needed for production and maintenance of the well; if over the course of the growing season the crops still appear to be under grown/ damaged we will work with the landowner to reclaim areas that need to be addressed.

COGCC Decision: Approved pending re-inspection

COGCC Representative: Approved pending re-inspection. Staff acknowledges that recent workover activities were conducted prior to inspection, however, it appears workover rig traffic has impacted crops around wellhead and outside of the established access road. This location will be inspected at a future date to verify crop establishment/health.
