<p><b>RECLAMATION COMMENTS</b></p> <p>Records show well was PA 02/10/2010. On 04/06/2023, Operator submitted Form 4 #403366873 stating "Final Reclamation complete". Operator comments state "This well site meets reclamation objectives and is ready for inspection. Site is well vegetated with 80% or better plant cover. Surface owner is utilizing this site as pasture land for cows. Original Sundry Attached with photo".</p> <p>It was observed in this inspection that the Location does not meet COGCC 1004 Reclamation requirements; Large areas of the Location are bare and unvegetated; Location has not achieved a uniform desirable perennial vegetative cover. Compaction issues appear to remain.</p> <p>It is also noted that the photo documentation provided within the sundry does not include the O&amp;G Location, but a fenced pasture land southwest of the Location's disturbance area. This does not comport with Rule 207 requirements.</p>	trujilloam	05/22/2023
