**General Comment:****COGCC Inspection Report Summary**

On 5/22/2023 at approximately 15:15, Compliance Inspector Matthew Morris conducted a follow-up inspection at TEP ROCKY MOUNTAIN LLC, BARRETT-66S96W/36SESW at Location ID #334947 in Garfield County, Colorado.

Corrective actions from FIR #699805487 for open-ended load line, unused equipment, secondary containment capacity, berm maintenance, and sediment trap maintenance have been completed. Normal production operations were observed.

During the inspection, the following compliance issues were observed:

- 1) Gas meter calibration record not conspicuously posted
- 2) Stormwater; refer to Stormwater section

A follow-up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.

This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, and/or Wildlife Management area.
