Comment:

It was observed in this inspection that the Location has not been reclaimed in accordance with Rule 1004 Requirements:

-With exception to the access road, Location has largely achieved a uniform, desirable perennial vegetative establishment.

-Access road, both leading to and on the Location, has not been decompacted, recontoured/regraded and reclaimed. BMPs at road have not been maintained; sediment due to runoff from the road observed discharged into drainage/wetland areas northwest of the Location.

Corrective Action:

Comply with COGCC 1004 Rules and conduct reclamation including, but not limited to, removal of culverts, compaction alleviation, recontoring/regrading (including drainages) and revegetation activities at the access road.

Install and maintain stormwater and erosion control BMPs to manage runoff, as well as to stabilize the seeded soils. Continue to monitor and manage Location for Undesirable Plant Species. Stormwater and Weed management required until Location receives a passing final reclamation inspection.
