On Wednesday, 5/24/2023, Inspector Kirby Burchett, conducted a routine field inspection at Crowheart Energy LLC on the Pepler Fee Com 12-18 well, Location #313060, in Moffat County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District with High Priority, NSO, Density and Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

While there during normal operations the following compliance issues were observed:

1. Random debris.
  2. Unused equipment.
  3. Burner stack on separator and lines open to wildlife.
  4. Unlabeled fiberglass tanks on location.
  5. Wellhead sign missing required information.
  6. Unmarked anchors

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with COGCC rules.
