 Field Inspector Actions:
 On 5-15-2023, I Adam Burns area field inspector was assigned a complaint received by COGCC staff in reference to Noise. The complainant Willaim Corcilus at 4200 E 168th Ave Brighton, CO 80602 stated the issues were occurring outside of complainant's home on 5-10-2023.
 The complainant's detailed description of the issues are in the form 18.
 On 5-22-2023, I performed a complete site inspection of the facility to investigate the noise portion of the complaint. While there, I did not hear any unusual noises. PDC Energy's company man on location informed me that they put rubber bumper guards on the casing string ends, and that they put a rubber pad on the pipe rack for the casing strings as well. The rig is running on-line power.
 On 5-23-23, I did deploy a sound meter from 5-23-23 at 12:17pm to 5-24-23 at 7:55am.
 On 5-24-23, after reviewing the sound data and comparing it to PDC Energy's third parties sound data, it appears to be out of compliance with the COGCC rules and regulations.
 COGCC noise survey results indicate noise levels exceed limits in Rule 423. Comply with Rule 423 for a noise mitigation plan. With a Corrective Action date of 5/30/23
 A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules.
 All information reviewed and site inspection information has been submitted to the COGCC for further review.

Corrective Action: **Comply with Rule 423 for a noise mitigation plan.**
