During this inspection the following compliance issues were observed:

1. Stormwater - Lack of stabilization/compaction/insufficient BMP's on lease road & on location with a CA date of 06/19/2023
2. Housekeeping - Wildlife/personnel hazard with a CA date of 06/11/2023

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
