The site is located in close proximity to Eagle's nest so all site activity has been suspended to comply with the COGCC CPW requirements. On 6/1/2023, KPK was granted short term variance to use a vacuum truck to lower the elevation of the water in the excavation. The water removal occurred that same day and removed 3 truckloads of water from the excavation. Water with a

sheen was removed at that time. KPK is willing to revisit the site if the COGCC and CPW will remove the access restrictions that protect the Eaglets
