Comment: The perennial vegetation cover has not established to at least 80% of reference area levels. There are areas of sparse vegetation and bare soils. It appears there are less noxious weeds at the location this season but follow up control will need to be performed. The location will need to be seeded and reclaimed to establish vegetation to 80% reference area levels. Previous corrective action has not been completed and will need to be addressed immediately.
