Comment: The topsoil plan is only indicating that the top 6 inches will be salvaged for construction at both the Ardourel well and tank pad. Soil data and onsite evaluations indicate topsoil which should include A and B horizons extending down to 8"-10" at the Ardourel tank pad and 12"-14" at the Ardourel well pad. At the time of inspection topsoil was in process of being salvaged and stockpiled at the Ardourel tank pad and it appeared there was 6-8" being salvaged. A follow up inspection will be looking for at least 8"-10" at the tank pad and 12"-14" at the well pad.

Corrective Action: Comply with 1002. b rules for soil removal and segregation
