On Thursday, 6/29/2023, Inspector Kirby Burchett, conducted a follow up field inspection at Utah Gas Op Ltd dba Utah Gas Corp on the Government 6-2X well, Location #315114, in Rio Blanco County, Colorado. This location is within or in close proximity to a Parks and Wildlife (CPW) District with High Priority, NSO, and Density Habitat regulations. Location is also within Public Water System (PWS) Protection, Rule 411.a regulations.

Follow up inspection in response to FIRR #403410573, from Corrective Action observed during Inspection #702501332 on 5/16/23. Not all Corrective Actions have been addressed.
