The lease operator was reviewing tank trending data and noticed a drop in tank level beginning on approximately July 4th. The lease operator went to the location and identified a hole near the bottom of the tank losing produced water into a dirt berm containment. The lease operator dispatched a water truck to empty the tank and the location was shut in.

Please note that this location is found within the Warm Zone of the Spring Creek Fire.

	Operator shall collect sample(s) from comparable, nearby non-impacted native soil for purposes of establishing background soil conditions including pH, electrical conductivity (EC) and sodium adsorption ratio (SAR), per Rule 915.e.(2).D.
	Per Rule 912.a.(2), the Operator will conduct sampling and analysis of soil, surface water, and groundwater--if encountered, to determine the horizontal and vertical extent of any contamination in excess of the cleanup concentrations in Table 915-1 for soil, surface water, and groundwater. The Operator shall analyze samples for the complete Table 915-1 list and shall compare analytical results for site investigation samples to both the Table 915-1 Residential Soil Screening Level Concentrations and the Protection of Groundwater Soil Screening Level Concentrations. Submit an assessment of potential pathways to groundwater via a Supplemental Form 19.
