Corrective Action:	<p>The well location appears to meet final reclamation regulations and standards, and appears reflective of reference areas. Unable to find evidence of oil and gas activities.</p> <p>The tank battery does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged and abandoned on 8/8/2018. gravel remains in the eastern portion of the disturbance and access roads have not been re-contoured or re-graded.</p> <p>Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p> <p>The corrective date is not intended to be the date for which the Operator shall complete the corrective actions but rather the corrective date is the date the location was observed out of compliance.</p>	Date <b>07/01/2023</b>
