I'm working with the Colorado Oil & Gas Conservation Commission (COGCC) to help Linde Inc and Messer LLC process operator transfers regarding a few CO2 wells in Montezuma county Colorado. I've copied Brad Pienta on this email; he is the Messer representative.

One of the COGCC conditions to approving the transfer of operator is that we need to provide the COGCC with Buyer Notified Local Govt.
