The above captioned Form 9 transfer has been reviewed and the following issues were noted.

**Issue 1:** the Subsequent Attestation is missing the Subsequent document number at the top of the page.

**Solution 1:** resubmit the Subsequent Attestation and include the Subsequent document number. Please email me the revised attestation and I will get it uploaded to the transfer.

**Issue 2:** Please provide a Buyer Notified Local Govt. Attestation. Certificate of Merger from the State of Delaware is not an attestation that the county of Montezuma was notified of the merger and transfer of the wells and facilities.

**Solution 2:** Please provide a Buyer Notified Local Govt. Attestation attesting that Sherrie "Jane" Duncan at Montezuma County was notified of the merger and transfer.

Assuming the other Form 9 requirements are met, all Form 9s shall now be passed with the following two COAs:

*The Buying Operator must file a Form 3, Financial Assurance Plan, within 10 business days of Form 9 approval. Per Rule 702, Buyer will then provide any required additional financial assurance as soon as practicable but no later than 90 days from the Commission's approval of the Form 3, Financial Assurance Plan.*

*The Selling Operator must file a Form 3, Financial Assurance Plan within 10 business days of Form 9 approval. Per Rule 702, Seller will then provide any required additional financial assurance as soon as practicable but no later than 90 days from the Commission's approval of the Form 3, Financial Assurance Plan.*

**Both operators will need to respond to this email accepting the COAs.**

When resubmitting the Form 3, please use the following Verbiage

*This Form 3 Document #\_\_\_\_ is submitted because of an approved Form 9 Transfer of Operatorship and it replaces Form 3 document #\_\_\_\_\_.*
