**CECMC Inspection Report Summary**

On Friday 7/28/2023, I, Inspector Scott Ramsey, conducted a routine inspection at TEP PA 42-33, at Location # 335411 in Garfield county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad. No evidence of a tracking pad on location.

During this inspection the following compliance issues were observed:

1. Meter calibration card not conspicuously posted.
2. Cut slope shows signs of erosion, lack of stabilization and is encroaching on production equipment.
3. Sediment trap at culvert needs maintained.
4. Random debris.

Refer to photograph of observed compliance issue.

A follow up on this site inspection may be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
