During this inspection, staff observed a partially buried flowline adjacent to the access road between the well location and the tank battery location. The former well location appears to be progressing towards Rule 1004 standards, however, the former tank battery location appears to be used as a storage yard. Additional reclamation activities are required in order for the location to meet final reclamation standards. Refer to attached inspection photos.
