**General Comment:****ECMC Inspection Report Summary**

On Thursday, 08/03/2023, Inspector Kirby Burchett, conducted a follow up field inspection at Robert L. Bayless Producer LLC. on the Zimmerman/Chamberlin 1 well, Location #313011, in Moffat County, Colorado. This location is within or in close proximity to a Parks and Wildlife (CPW) District with High Priority, NSO, Density and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

As noted in previous Inspections personal and unused equipment continues to be stored on location.

Follow up inspection in response to compliance issues observed during Inspection #702501388 on 5/30/23. No Corrective Actions have been resolved. Previous CA due dates will not change.

While there during normal operations the following compliance issues were observed as in previous inspection:

1. Random debris.
2. Unused equipment.
3. Equipment and lines open to wildlife.
4. Stained soils around pumping unit and tank battery.
5. Insufficient Stormwater BMPs.
6. Personal equipment storage on location.

The following compliance issue was observed during this inspection:

1. Wellhead sign lacking required information.
