A site investigation was conducted pursuant to COGCC Rule 911 at the LILLI UNIT T8N-R58W-S4 L01 Tank Battery location.

Eight (8) grab confirmation soil samples will be collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Additionally, two (2) soil samples were analyzed for metals in soil per COGCC Table 915-1. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The COGCC Tank Battery and Produced Water Vessel Closure Checklists was utilized and filled out during the abandonment process. A photolog was submitted on the Subsequent Form 27.

Confirmatory soil samples were collected for analysis of TPH C6-36, organic compounds in soil per COGCC Table 915-1, and cadmium per the approved amended sampling plan documented under COGCC document number 403150018. A detailed remedial excavation report and NFA request will be submitted on the next Form 27.
