Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

Following the installation of new pipeline, the system was pressure tested and fluid was observed seeping from the soil within the excavation area of the new pipeline. The fluid was likely coming from a buried flowline connected to the nearby drip tank. The pipeline system was immediately blown down and isolated to stop the release. The released fluid did not leave the excavation area. No fluid was recovered.

Unknown volume of produced water. Will be determined during pipeline repair. Soil samples were collected on 8/5/23. Laboratory analytical results are pending.

Depth to groundwater based on well construction report for well permit #315724. Soil samples were collected 8/5/23 and laboratory analytical results are pending. Extent of release unknown at this time, but will be determined during pipeline repairs. La Posta Canyon drainage is approximately 100 feet to the north of the Point of Release, but the drainage was dry at the time of release discovery and there were no signs of impacts to the drainage.
