KMOG evaluated unaffiliated drainage from the applicable agricultural field and installed a straw bale barrier along the neighboring fence line of the complainant property to serve as energy dissipation for the uncontrolled tail waters. This is a temporary measure due to safety working within a pressurized lay flat line. Additional mitigation measure may be implemented once the line is done with its current completions services and temporarily offline for equipment move.
