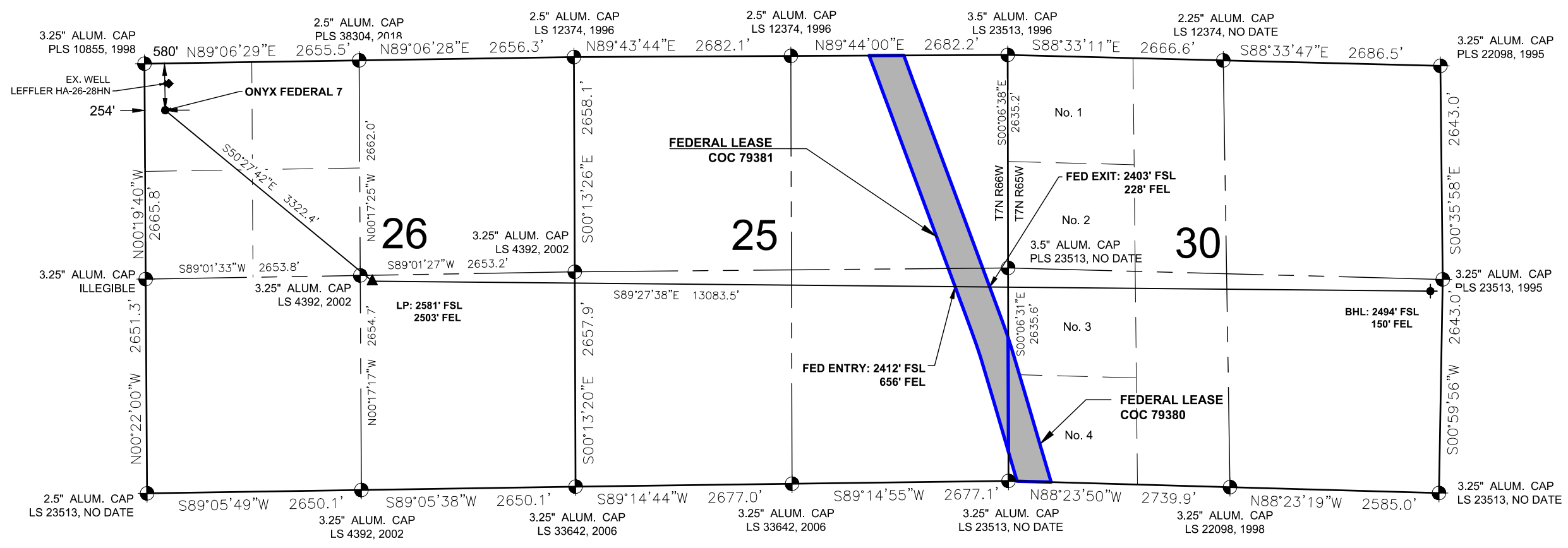


ONYX FEDERAL 7

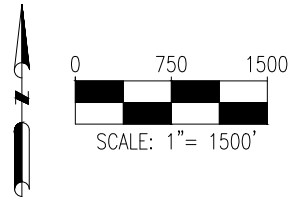
