Unable to find evidence of oil and gas activities and/or disturbances.</p> <p>The tank battery does not comply with Rule 1004. Majority of eastern portion of the tank battery disturbance shows stunted growth and does not reflect the reference areas. Site investigation into why the crops are stunted is required.</p>	
Corrective Action:	<p>Comply with Rule 1004.
