Corrective Action:	<p>The well location and access road appear to meet final reclamation regulations and standards, and appear reflective of reference areas. Unable to find evidence of oil and gas activities and/or disturbances.</p> <p>The tank battery and associated access road does not comply with Rule 1004. Majority of the tank battery shows stunted growth and does not reflect the reference areas. Site investigation into why the crops are stunted is required.</p> <p>Comply with Rule 1004.
