There are some desirable species beginning to establish but there are undesirable weeds which will need to be controlled (e.g. mowed). The reclamation area is fenced with a 1 strand electric wire fence. The remainder of the access road to the south has not been recontoured and reclaimed. The location will remain out of compliance until all reclamation is completed.
