Basis for change in implementation schedule:

**OPERATOR COMMENT**

Due to the new sampling guidance, the use of composite samples is no longer allowed for final closure. However, Operators may use Rule 915.e.(2)c. to request a reduction to the list of contaminants on a case-by-case basis. Per this rule and guidance from the EPS, the attached analytical results demonstrate that the CBM produced water does not contain liquid hydrocarbons and a reduction in the 915-1 constituents could be reduced. Therefore, impacts from organic compounds are not as likely from coal bed methane "CBM" produced water. As such, analysis of some Table 915-1 Organic Compounds in Soils or other contaminants of concern may not be necessary to analyze for closure of CBM produced water Pits. Attached analytical results from the Black Gold 32-33 well demonstrate that the CBM produced water does not contain liquid hydrocarbons and we are requesting a reduction in the 915-1 constituents to match the Soil Suitability for Reclamation list of EC, SAR, pH and boron.
