Comment:

This location does not comply with Rule 1004. During this inspection, Staff observed that the access roads do not appear to have been reclaimed with evidence of contouring issues. Additionally, the former location does not appear to be progressing towards Rule 1004 regulations and standards as undesirable vegetation (e.g. russian thistle and kochia; and CO List B Noxious weed- scotch thistle) was observed to be growing throughout. Roadbase/gravel remains throughout portions of the location and will need to be removed. The location does not appear to be properly stabilized as cut slopes are void of vegetation and require additional contouring to reflect pre-disturbance topography. Refer to attached inspection photos for documentation.

Corrective Action:

Comply with Rule 1004. Location will remain out of compliance until the corrective action has been resolved.
