<p>COGCC Inspection Report Summary On Wednesday 9/13/2023 at approximately 14:30 hours, I, Inspector Tom Peterson, conducted an on-site inspection at the PDC Energy Tailholt FD Tank Battery 11-2D location #442936 in Weld County, Colorado. While there, I observed trash on location, the crude oil tanks lacked placards, and the bulk lube oil storage wildlife netting needed to be reinstalled. The following possible compliance issues were observed: Rule 605.h. with a corrective action date of 10/16/2023, Rule 606. with a corrective action date of 10/16/2023, Rule 902.b. with a corrective action date of 10/16/2023. A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
