**COGCC Inspection Report Summary****\*\*Weather Conditions: sunny, dry ground.**

On Thursday, August 31, 2023 at approximately 0945, I, Inspector Brittani Santistevan, conducted an on-site inspection at WARNER 35, 33-18 (Kerr McGee Oil &amp; Gas Onshore), at location #: 423043 in WELD COUNTY Colorado.

While there, I observed temporarily abandoned wellheads.

During this inspection the following possible compliance issues were observed:

1. It appears to be "trash" (cones, wood pallet) at wellheads. Remove to comply with Rule 606. (Corrective Action Date: September 14, 2023) See attached photo #3, 4.

2. It appears to be disconnected/unused equipment near the wellheads. Remove or reconnect to comply with Rule 606. (Corrective Action Date: September 14, 2023) See attached photo #4, 7.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
