Comment: The perennial vegetaion has not re-established and there is an area approximately 200'x30' that has undesirable weeds and bare soils. The area reclaimed at the north side of the location which was stabilized with straw blanket has re-established perennial vegetation. The bare areas of the location will need to be reseeded and reclaimed. An agronomic soil analysis should be performed to evaluate soil conditions. Corrective action will remain out of compliance until completed.
