Comment

Operator has performed interim reclamation activities to reduce disturbance areas only needed for production operations with the evidence of desirable perennial vegetation. However, there are areas throughout the northern, eastern and southern interim reclamation, including the flowline area, with predominately weedy, annual vegetation consisting of tumbleweeds.

Corrective Action

Comply with Rule 1003 to perform additional reclamation in accordance to Rule 1003. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards.
