Comment:

This location does not comply with Rule 1004. During this inspection, Staff observed that the former location and access road does not appear to be progressing towards Rule 1004 regulations and standards. The location has evidence of bare/exposed soils, undesirable vegetation (e.g. russian thistle and kochia) was observed throughout, debris and stained soils remain on location, the access roads do not appear to have been reclaimed, and the vegetative cover within the reclamation area is not reflective of reference area crop. Refer to attached inspection photos.

Corrective Action: **Comply with Rule 1004. The location will remain out of compliance until the corrective action has been resolved.**
